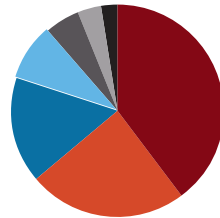

Equity Sector Weights

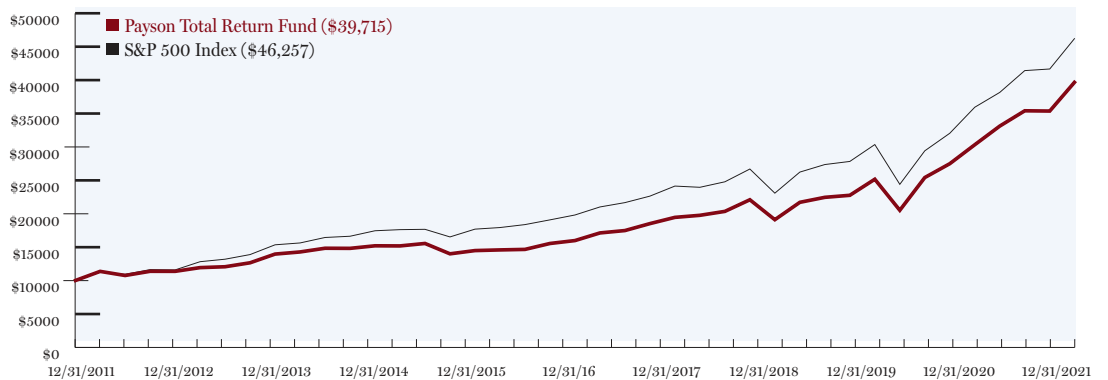
