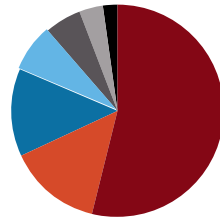

## Equity Sector Weights



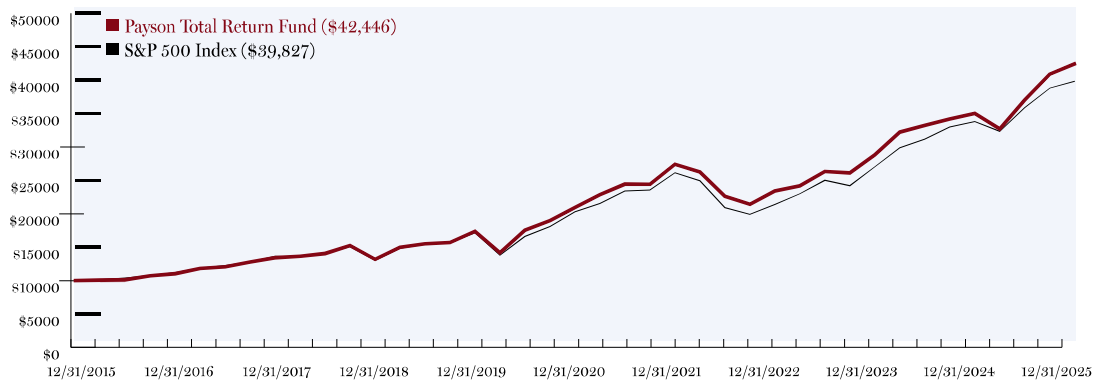
